The undersigned, for the purpose of forming a corporation, under the Florida General Corporation Act hereby adopt the following articles of incorporation:

**ARTICLE ONE
NAME**

The name of the corporation is ORLANDO INTERNET COMMUNICATIONS, INC. The principal office address of the corporation is 10304 Belgrove Place, Orlando, Florida 32817.

**ARTICLE TWO
DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE THREE
PURPOSE**

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

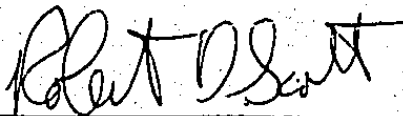
