ARTICLE ONE

The name of the corporation is **INNOVATIVE DIFFERENT EFFECTIVE ALTERNATIVE SPECIALISTS, INC.** The principal address of the corporation is: 1859 N. Pine Island Road, Suite 205, Plantation, Florida 33322-5224.

ARTICLE TWO
