ARTICLES OF INCOMPORATION

OF

USABIA, INC. (A profit corporation)

The undersigned, John Coetnes whose post office address is 7601 E. Tressure Dr. #410 Mismifleach, Fl. 33141, does under and by virtue of the laws of the State of Florida authorising the formation of corporation, hereby forms a corporation.

ARTICLE I

NAME AND PLACE OF BUSINESS

The name of this corporation shall be USASIA, INC. And shall conduct its operation and its place of buciness principally within the United States and incidentally outside the territory of the United States including any foreign country as may be determined by the By-laws except as restricted herein.

TERM OF EXISTENCE

The duration of this corporation shall be perpetual.

PURPOSES

The general purposes for which this corporation is organized are:

- a) The aggregate number of shares which the Corporation is authorized to issue is Ten Thousand (10,000) shares, having a par value of Ton Dollars (\$10.00) each.
- b) In the event of any liquidation, dissolution, or winding up of the Corporation, whether voluntary or involuntary the holder of the shares shall receive, out of the assets of the Corporation remaining after debts and liabilities have been paid, according to the number of the shares held.
- c) No stockholder shall have the right to sell, asign, pledge, encumber, transfer, or otherwise dispose of any of the shares of the Corporation stock without first advising the Corporation of such sale.
- d) All of the issued and outstanding shares of the corporation stock shall be made subject to restrictions on their transferability by agreement among the holders of such shares or between the holders of such shares and the corporation A copy of the agreement shall be kept on file with the secretary of the corporation at reasonable times during business hours. Shares of stock in this corporation shall not

be transferred or sold until the sale or transfer has been reported to and approved by the Board of Directors.

ARTICLE V

POWERS

The corporation is to have any and all powers to do any and all things nocessary or expedient to carry out the purposes and objectives of this corporation and as may be determined by the Board of Directors and subject to the bi-lave and to possess all rights, privileges and immunities and to enjoy benefits granted corporations under the laws of the State of Florida.
