**ARTICLES OF INCORPORATION
OF
MEGACALL, INC.
A FLORIDA CORPORATION**

The undersigned, acting as Incorporator of MEGACALL, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

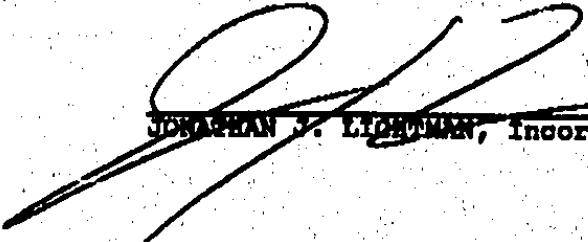
