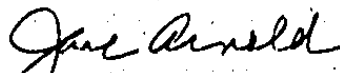

ARTICLES OF INCORPORATION  
OF

TIMESAVERS UNLIMITED, INC.

Article I - Name

The name of this corporation is TIMESAVERS UNLIMITED, INC.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue 5,000 shares of one dollar (\$1.00) per value common stock.

Article V - Initial Registered  
Office and Agent

The street address of the principal office and initial registered office of this corporation is 11138 Scott Mill Road, Jacksonville, Florida 32223. The mailing address of the name of the initial registered agent of this corporation at that address is Jane J. Arnold.

Article VI - Initial Board of Directors

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the Bylaws, but shall never be less than one(1). The name and address of the initial director of this corporation is:

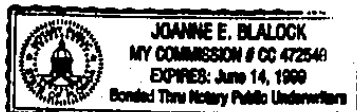

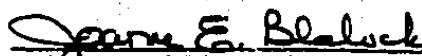
