

ARTICLE I

EFFECTIVE DATE

NAME

7-2-96

The name of this corporation shall be: RAPPAHANNOCK EQUITY GROUP, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

CAPITAL STOCK
