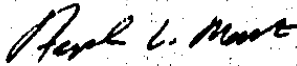

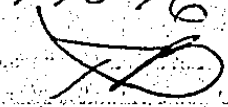

**FIRST:** The name of this corporation is **LAKELAND COURIER SERVICE, INC.**

**SECOND:** The general nature of the business or businesses to be transacted by this Corporation, together with and in addition to those powers conferred by the laws of Florida and the United States of America and the principles of common law upon corporations organized under and by virtue of the laws of Florida, is providing courier service.

**THIRD:** The maximum number of shares of stock that this Corporation is authorized to have outstanding at one time is Ten Thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

**FOURTH:** The amount of capital with which this Corporation will begin business is Five Hundred Dollars (\$500.00).
