The undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract hereby form and establish a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is NAPIER'S MOBILE MARINE, INC.

ARTICLE II. DURATION

This corporation shall exist for a perpetual period, commencing at the time of the filing of these Articles of Incorporation by the Florida Department of State.

ARTICLE III. PURPOSE

This corporation is formed to transact mobile marine sales, repairs and related services and any and other all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV. AUTHORIZED SHARES


