ARTICLE I

Name

The name of this Corporation shall be Noric Ocean, Inc.

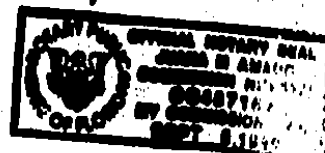
