ARTICLES OF INCORPORATION OF BILL WEBBER, INC.

ARTICLE I. NAME

The name of the corporation is Bill Webber, Inc.

ARTICLE II. DURATION

The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as hereafter provided or hereafter amended.

ARTICLE III. PURPOSE

The purpose of the corporation is to provide general contracting services which include, but is not limited to, all types of construction, maintenance, and design regarding real estate improvement, and any other lawful business purpose.

ARTICLE IV. CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 500 shares. Such shares shall be of a single class of common stock, and shall have a par value of Ten Dollars (\$10.00) per share.

ARTICLE V. CAPITALIZATION

The amount of capital with which the corporation will begin to will not be less than \$5,000.00.

ARTICLE VI. PRINCIPAL OFFICE AND REGISTERED AGENT

The address of the corporation's principal office is 6706 Spanish Moss Drive, Keystone Heights, Florida 32656. The name of the initial registered agent of the corporation, located at 1027 Blackstone Building, 233 East Bay Street, Jacksonville, Florida 32202, is Gerald S. Bettman.

ARTICLE VII. CORPORATE POWERS

The corporation shall have all the rights and powers now or hereafter conferred on corporations by the laws of the State of Florida.

ARTICLE VIII. INCORPORATOR

The name and address of the person signing these articles of incorporation as a subscriber and/or incorporator is William Richard Webber, 6706 Spanish Moss Drive, Keystone Heights, Florida 32656.

ARTICLE IX. INITIAL BOARD OF DIRECTORS

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is one, and the name and address of the initial director is:

The initial director shall hold office until his successors are elected and qualified as provided in the bylaws. Thereafter the term of office of each director shall be five years and until the election and qualification of a successor. The number of directors set forth herein and constituting the initial board of directors shall be the authorized number of directors until such number is changed by a bylaw duly adopted by the shareholders.

ARTICLE X. BYLAWS

The initial director shall submit the proposed bylaws not more than 10 days following the issuance of the Certificate of Incorporation.

ARTICLE XI. DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.

ARTICLE XII. INDEMNIFICATION

The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

ARTICLE XIII. AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.
