ARTICLE 1

NAME

The name of this corporation is: Frederick B. Karl, Jr., P.A.

ARTICLE 2

DURATION

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE 3

PURPOSES

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of common voting stock having a par value of one dollar (\$1.00) per share. The capital stock of the corporation may be issued for real or personal property, services, or any other right or thing having value, in the judgment of the Board of Directors, at least equal to the full par value of the stock so to be issued, and, when so issued, such stock shall be fully paid and nonassessable.

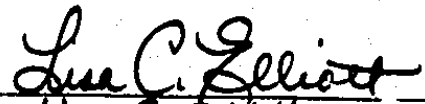
