ARTICLES OF INCORPORATION

OF

J J BALES & SERVICE, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name and address of the corporation is J J SALES & SERVICE, INC., 2905 West McGee Road, Plant City, FL 33565.

ARTICLE II. NATURE OF BUSINESS
