The undersigned subscriber to these Articles of Incorporation desiring to form a Professional Association under the Laws of the State of Florida, does hereby accept all the rights and privileges, benefits and obligations conferred and imposed by said laws and does hereby adopt the following Articles of Incorporation as the Charter of the Professional Association hereby organized.

ARTICLE I

NAME

The name of the Professional Association shall be:

DURATION

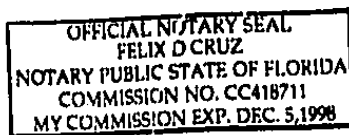
