The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation.

- 1. The name of the corporation is Joy Luck Herbal Garden Company.
- 2. The street address of the initial principal office of the corporation is 696 First Avenue North, Suite 400, St. Petersburg, Florida 33701.
- 3. The duration of the corporation is perpetual.
