The name of this corporation is LARAMAR MEDIA, INC.

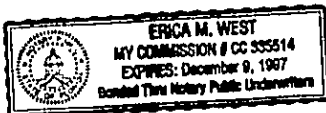


