## ARTICLES OF INCORPORATION OF SANZS ESTHETIC UNISEX SALOON, INC.

The undersigned incorporator to these Articles of Incorporation, a naturall person competent to contract, by these articles form a corporation for profit, pursuant to the laws of the State of Florida.

FIRST: The name of the corporation is SANZ'S ESTHETIC UNISEX SALOON, INC.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The nature of the business and the objects and purposes to be transacted and carried on are to engage in any activity or business as lawfully permitted under the laws of the State of Florida and the United States of America.

FOURTH: The aggregate number of shares of Capital Stock which the Corporation has authority to issue is 5,000 (five thousand), all of which shall be one class of common stock having a par value of \$1.00 each.

FIFTH: The address of its initial registered office is 474 E 49th. St. #103, Hialeah, Florida 33013, and the name of the initial register agent at such address is ESPERANZA SANZ

SIXTH: The initial board of directors will consists of one director, whose name and address is, ESPERANZA SANZ, 474 E 49th. St. #103, Hialeah, Florida 33013. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one.

THIRTEENTH: The power to adopt, alter or repeal bylaws shall be vested in the board of directors and the stockholders, except that the board of directors may not amend or repeal any bylaw adopted by the stockholders if the stockholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.




