ARTICLE I be and it is hereby amended to read as follows:

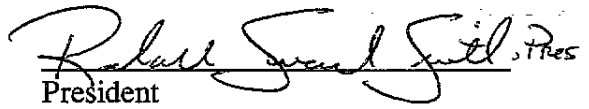
"The name of this corporation is Addison Technology, Inc."

The foregoing amendment was adopted by the Stockholders and Directors of the corporation on the 19th day of November, 1997.

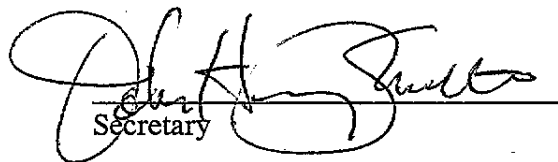
