ARTICLE III-PURPOSE

This corporation is organized for the following purposes:

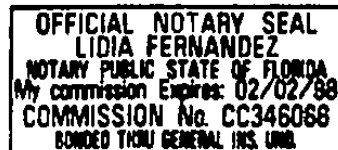
