ARTICLE I - NAME

The name of this corporation is Litigation Education Services, Inc..

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on July 5, 1996.

Every stockholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
