**NUMBER OF DIRECTORS FIRST BOARD:** The number of directors constituting the first board is one.

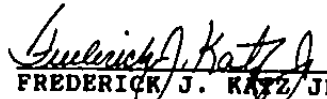
**ARTICLE VIII**
