ARTICLES OF INCORPORATION  
of  
DEERE ENVIRONMENTAL, INC

We, the undersigned, associate ourselves to become a Florida Corporation for profit.

I

The name of the Corporation shall be DEERE ENVIRONMENTAL, INC. 1001 West Newport Center Drive, Ste. 109, Deerfield Beach, FL 33442.

II

The Corporation may engage in any activity of business permitted under the Laws of the United States and of this State.

III

The maximum authorized capital stock of this corporation shall be five hundred shares of common stock with a par value of one dollar per share.

IV

This Corporation shall have a perpetual existence.

V

The initial registered office of this Corporation shall be 1001 West Newport Center Drive, Suite 109, Deerfield Beach FL 33442, with the privilege of having branch offices at any other places within or without the State of Florida.
