

ARTICLES OF INCORPORATION DIVISION OF CORPORATIONS LAREDO & LEFTY FOODS, INC.

THE UNDERSIGNED, acting as sole incorporator of Laredo & Lefty Foods, Inc. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation for the Corporation, effective as of July 10, 1996, pursuant to Section 607.0203(1) of the Florida Statutes:

ARTICLE 1 Name

The name of the Corporation is: Laredo & Lefty Foods, Inc.

ARTICLE 2 Effective Date

Pursuant to the provisions of Section 607.0203(1) of the Florida Statutes, these Articles of Incorporation shall have an effective date of July 10, 1996.

ARTICLE 3 **Business and Activities**

The Corporation may, and is authorized to, engage in any activity or business now or hereafter permitted under the laws of the United States and of the State of Florida.

ARTICLE 4 Shares

The total number of shares of all classes of capital stock that the Corporation shall have the authority to issue shall be Ten Million (10,000,000) shares, consisting of a single class of common stock having a par value of \$0.01 per share.

ARTICLE 5 Preemptive Rights.

No shareholder of the Corporation shall have any preferential or preemptive right to subscribe for or purchase from the Corporation any new or additional shares of capital stock, or securities convertible into shares of capital stock, of the Corporation, whether now or hereafter authorized.

ARTICLE 6 Principal Office and Mailing Address

The address of the Principal Office of the Corporation and its mailing address is C/o Martin A. Traber, Esq., Poley & Lardner, 100 North Tampa Street, Suite 2700, Tampa, FL 33602. The location of the Principal Office and the mailing address shall be subject to change as may be provided in the Bylaws.

ARTICLE 7 Initial Board of Directors

The number of the Directors constituting the initial Board of Directors of the Corporation is one (1). The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than one (1),
