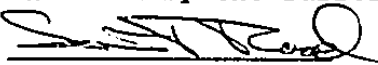

ARTICLE 10, Initial Capitalization of this corporation is \$1,000.00.

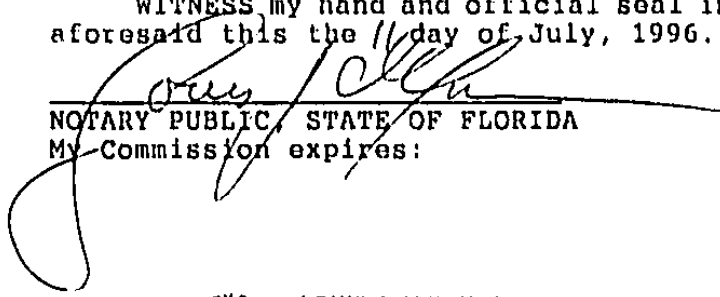
