By these Articles of Incorporation the incorporator forms a corporation for profit under Florida Law.

ARTICLE I

The name of this corporation is Quest Services, Inc.

ARTICLE II - TERM

This corporation shall exist perpetually. Corporate existence shall commence on May 24, 1996.

ARTICLE III - PURPOSE

The purpose of this Corporation is to transact any and all lawful business for which Corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of common stock with par value of \$1.00 per share.

ARTICLE V - INITIAL CAPITAL

The amount of capital with which this corporation will begin business shall not be less than five hundred dollars (\$500.00).
