OF

ARTICLE I

The name of this Corporation is: BCT Aero, Inc.

This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.

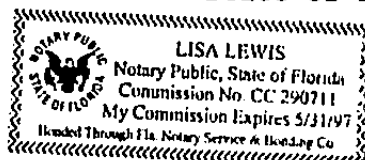


