

THE UNDERSIGNED, acting as sole incorporator of RAYNOR AUTOMOTIVE, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is Raynor Automotive, Inc. (The "Corporation").

ARTICLE II

Principal Office and Mailing Address

The principal office and mailing address of the Corporation is 3025 Beauclerc Oaks Court, Jacksonville, Florida 32267. The location of the principal office and mailing address shall be subject to change as may be provided in the Bylaws duly adopted by the Corporation.

ARTICLE III

Shares

The number of shares which the Corporation shall have authority to issue is One Thousand (1,000), consisting of a single class of common stock, one cent (\$0.01) par value per share.

ARTICLE IV

Initial Registered Office and Agent

The address of the initial Registered Office of the Corporation is 3025 Beauclerc Oaks Court, Jacksonville, Florida 32257, and the initial Registered Agent at such address is Jeffrey D. Raynor.

ARTICLE V

Initial Board of Directors

The number of Directors constituting the initial Board of Directors of the Corporation is two (2). The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than two (2). 
