# ARTICLES OF INCORPORATION 96 JUL 12 /N 8:35 OF S. I. PARK ENTERPRISES, INC. TALL MARKED AND A STATE OF THE ST

The undersigned, acting as the Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE I**

The name of this corporation is S. I. PARK ENTERPRISES, INC.

#### **ARTICLE II**

The period of its duration is perpetual.

#### **ARTICLE III**

The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

#### **ARTICLE IV**
