ARTICLES OF INCORPORATION  
OF  
Trans International, Inc.

THE UNDERSIGNED, Marcel Rif executed the following documents as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be: Trans International, Inc.

ARTICLE II

EXISTENCE

This corporation shall commence existence upon:

The filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE III

NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation and its objects and powers shall be as follows:

To transact any and all lawful business under the laws of the United States and of the State of Florida.

#### ARTICLE IV

##### CAPITAL STOCK

a. The aggregate number of shares which this corporation shall have authority to issue is the total sum of One Million (1,000,000) shares, having an individual par value of one cent (\$.01) per share.

b. The capital stock may be paid for in property, labor, services or cash.

c. Unless otherwise stated in these articles, or in an amendment to these articles, there shall be only one (1) class of stock of this corporation.

#### ARTICLE V

##### INITIAL CAPITAL

The amount of capital with which this corporation will begin business shall not be less than One Hundred (\$100.00) Dollars.

#### ARTICLE VI

##### INITIAL REGISTERED OFFICE AND AGENT

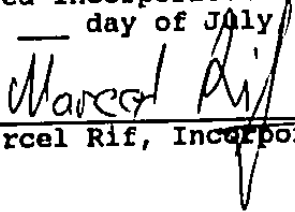

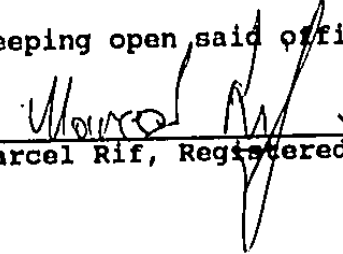
