Articles of Incorporation of Great Music, Inc. A Florida corporation



The undersigned incorporator, pursuant to Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation for Great Music, Inc., a Florida corporation.

Article I. Name

The name of the corporation is: Great Music, Inc.

Article II. Address

The principal office and mailing address of the corporation is: 350 Sylvanian Boulevard, Winter Park, FL 32789.

Article III. Authorized Shares

The aggregate number of shares that the corporation shall have authority to issue is 1,000 shares without par value common stock.

Article IV. Registered Office and Registered Agent

Article V. Incorporator
