ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME AND MAILING ADDRESS

DURATION

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgement of these Articles of Incorporation.





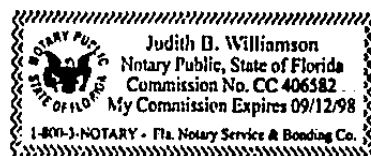
