ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles Fof Incorporation, a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.



ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation is PROFESSIONAL VIDEO AND ACCESS CONTROL Corporation, with its principal place of business located at 1351 Southeast 7th Avenue, Unit 203, Dania, FL 33004.

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE
