ARTICLES OF INCORPORATION  
OF  
WINDSOR ACADEMY, INC.

THE UNDERSIGNED, acting as incorporator of a corporation  
under the Florida General Corporation Act, adopts the following  
Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is WINDSOR ACADEMY, INC.

ARTICLE II - PRINCIPAL OFFICE AND NATURE OF BUSINESS

The principal place of business and mailing address of the  
corporation shall be 7307 Twelve Oaks Boulevard, Tampa, FL 33634.

The purpose of this corporation is to provide educational  
services and engage in any other activity or business permitted  
under the laws of the United States and Florida.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which this corporation shall  
have authority to issue is 1000 shares of Class A stock at \$1.00  
par value per share. Fully-paid stock of this corporation shall  
not be liable to any further call or assessment. The sum of the  
par value of all shares of capital stock of the corporation that  
have been issued shall be the stated capital of the corporation at  
any particular time, to the extent of the par value of such

shares, and the excess, if any, of consideration received for such shares shall constitute capital surplus.

#### ARTICLE IV - TERM OF EXISTENCE

The duration of this corporation is perpetual.

#### ARTICLE V - AMENDMENT

These Articles of Incorporation may be amended, altered, changed or repealed by the affirmative vote of a majority of the stock issued and outstanding, at a Shareholders meeting called for that purpose.

#### ARTICLE VI - SHAREHOLDER RIGHTS

Shareholders of the corporation shall not have preemptive rights to acquire their pro rata share of stock of the corporation for all issues of any class of stock of the corporation, no matter when authorized.

This article pertaining to preemptive rights may not be amended or deleted without the unanimous vote of the Shareholders of each affected class, and no issuance of stock of the corporation shall take place unless the price at which the stock is to be issued shall be approved by a majority of the Shareholders of the corporation.

#### ARTICLE VII - INITIAL OFFICE AND AGENT

The street address of this corporation's initial registered

office in Florida is 6920 Hanley Road, Tampa, FL 33634 and the name of the initial registered agent at that address is Cynthia Cornelius.

#### ARTICLE VIII - DIRECTORS

The number of directors constituting the initial Board of Directors of this corporation is Two (2 ). The name and address of persons who are to serve as Directors until the first annual meeting of Shareholders, or until their successors are elected and qualify, are:

#### ARTICLE X - COMMON DIRECTORS - TRANSACTIONS BETWEEN CORPORATIONS

No contract or other transaction between this corporation and one or more of its Directors or any other corporation, firm, association or entity in which one or more of its Directors or any other corporation, firm, association or entity in which one or more of its Directors are directors or officers or are financially

interested, shall either be void or voidable because of such relationship or interest, or because such Director or Directors are present at the meeting of the Board of Directors, or a committee thereof which authorizes, approves or ratifies such contract or transaction, or because of his or their votes are counted for such purpose if: (a) the fact of such relationship or interest is disclosed or known to the Board of Directors or committee which authorizes, approves or ratifies the contract or transaction by vote or consent sufficient for the purpose without counting the votes or consents of such interested Director; or (b) the fact of such relationship or interest is disclosed or known to the Shareholders entitled to vote and they authorize, approve or ratify such contract or transaction by vote or written consent; or (c) the contract is fair and reasonable to the corporation.

Common or interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or committee thereof which authorizes approves or ratifies such contract or transactions.

#### ARTICLE XI - BYLAWS

The Bylaws of the corporation shall be initially adopted by the Board of Directors, and may be changed or repealed by the affirmative vote of a majority of the Board of Directors or by the affirmative vote of a majority of Shareholders at any meeting thereof.

ARTICLE XII - MISCELLANEOUS

Other lawful provisions, if any, concerning the stock of this corporation, or for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its Directors or Shareholders, or of any class of Shareholders: None.
