Please find enclosed our check for \$150. This is per conversation yesterday with Matt at your help line (850) 245-6056.

Filing and check no 2052 were sent by Airmail from London on April 4th. FYI, a letter re corporate resolutions was sent to my lawyers same day and they received 10 days later.

As check and filing was sent from overseas and given the vagaries of overseas post, we did want to make sure you had received prior to deadline of April 30th. So my lawyer's office called your department towards end of April to be told that probably check had been received but your department couldn't tell as there was a big back log. Since then, as check had not cleared my account, I have telephoned and spoken to Matt at least 3 times, last being in June. Again, Matt indicated a back log of checks being processed.
