ARTICLE ONE - NAME

The name of this corporation is: RKGV, Inc.

ARTICLE TWO - DURATION/ EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of execution of these Articles of Incorporation.


ARTICLE TEN - BYLAWS

The holders of outstanding shares of the voting stock of the corporation may act by written agreement without a meeting, as provided in Florida Statutes 607.0704.




