**ARTICLES OF INCORPORATION
OF
HYACINTH PUBLICATIONS, INC.**

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be: **HYACINTH PUBLICATIONS, INC.**

**ARTICLE II
DURATION**

The corporation shall exist in perpetuity.

**ARTICLE III
PURPOSE**

The corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV
CAPITAL STOCK**

The corporation is authorized to issue (1,000) shares of nonpar value voting common stock which shall be designated "Common Shares".

**ARTICLE V
RIGHT OF SHARES OF CAPITAL STOCK**

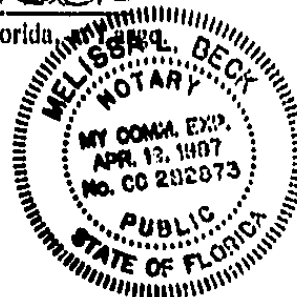


