The undersigned, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is KOHLER-NICHOLS, INC.

CORPORATE DURATION

The duration of the corporation is perpetual.
