The UNDERSIGNED for the purpose of forming a Corporation under the Florida General Corporation Act, dose hereby adopt the following Articles of Incorporation:

I. NAME: The name of the Corporation is:

Installation Center, Inc.

II. DURATION: The duration of the Corporation is perpetual, and the Corporate existence is to commence upon the filing of these Articles of Incorporation by the Department of State.

III. GENERAL PURPOSE: The general purpose for which the Corporation is organized are to transact any lawful business for which corporation may be incorporated under the Florida General Corporation Act, and to engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to any other business of the Corporation.

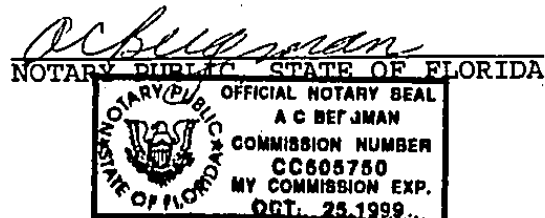
