1, the undersigned, hereby enter into this Certificate of Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State providing for the formation, liability, right, privileges and immunities of a corporation for profit.

ARTICLE

The name of the corporation shall be R&R Brightwork, Inc.

ARTICLE II

The general nature of the business to be transacted by this corporation is as follows:

- A. Perform boat repairs and maintenance on commercial and private vessels.
- B. To perform boat repairs and maintenance on commercial and private vessels to the public at large and whoever else may be interested in having boat repairs and maintenance to their vessels that may be deemed to be in the best interest of the corporation.
- C. To acquire by purchase, subscription or otherwise and to hold for the purpose of investment or otherwise and to own, sell or otherwise dispose of and deal in stocks, bonds, mortgages, securities, notes, commercial papers, or other wise deal with other evidence of debt, issued by
