THE UNDERSIGNED, acting as sole incorporator of Ada Anderson Paralegal Services, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be ADA ANDERSON PARALEGAL SERVICES, INC., and the corporate address shall be 3152 South Orange, Avenue, Orlando, Florida 32806.

ARTICLE III

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

Preemptive Rights Granted


Each shareholder of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation.

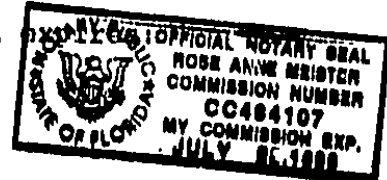
