**DOES HEREBY CERTIFY:**

**FIRST,** that a meeting of the Board of Directors of **SANDY CREEK OSTRICH RANCH INC.** resolutions were duly adopted and filed with the Minutes of the corporation setting forth a proposed amendment to the Articles of Incorporation, declaring said amendment advisable and calling a meeting of the shareholders of said corporation pursuant to Florida Statute 607.0705 for consideration thereof. The resolution setting forth the proposed amendment is as follows:

**RESOLVED,** that the Articles of Incorporation be amended by increasing the authorized capital stock of the corporation to be designated as common shares and the common shares to be increased from 100 shares no par value to 5,000,000 shares no par value

**SECOND,** that thereafter, pursuant to a resolution of the Board of Directors, a special meeting of the stockholders of said corporation was duly called and held, at which meeting the number of shares as required by statute were voted in favor of the amendments.

**THIRD,** that said amendments were adopted pursuant to 607.1003 Florida Statutes on November 20, 1996
