ARTICLE I - NAME

ARTICLE XIII - CAPITAL AMOUNT



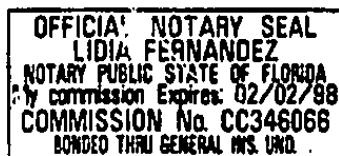
