ARTICLES OF INCORPORATION
OF

The undersigned Incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be: UNITED PACK & SHIP, INC.

ARTICLE II. INITIAL REGISTERED OFFICE AND MAILING ADDRESS

The street address of the initial registered office of this corporation is 10075 S. Federal Hwy., Port St. Lucie, Florida 34952. The mailing address of this corporation is 10075 S. Federal Hwy., Port St. Lucie, Florida 34952.

ARTICLE III. CAPITALIZATION

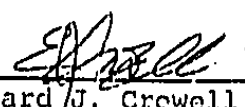

ARTICLE XI. INDEMNIFICATION

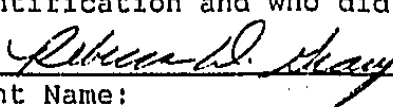
