ARTICLES OF INCORPORATION

OF

BUFFALO'S ORIGINAL WINGS & RINGS VIII, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Corporate Name. The name of the corporation is **BUFFALO'S ORIGINAL WINGS & RINGS VIII, INC.**

ARTICLE II

Duration. The duration of this corporation is perpetual.

ARTICLE III

Purpose. The general purpose for which the corporation is organized are the following:

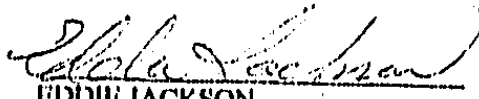
