ARTICLES OF INCORPORATION

FOR

T&SINSTALLALLING



The undersigned incorporators, by these Articles associate themselves for the purpose of forming a corporation pursuant to the laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

ARTICLE 1 _NAME__

The name of the corporation shall be T & S INSTALL ALL, INC., whose mailing address is 1420 Michigan Avenue, Miami Beach, Florida 33139.

ARTICLE 2 DURATION AND EFFECTIVE DATE

This corporation shall commence its existence on July 9, 1996 and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE 3 PURPOSE

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE 4 DEFINITIONS

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

Upon the sale for eash of any new stock of the same kind, class or series as that which he already holds, every shareholder of this corporation shall have the pre-emptive right to purchase his pro-rata share thereof at the price which it is offered to others, whether or not in excess of par. Fractional shares need not be issued on account of this provision.

ARTICLE 6 INITIAL REGISTERED AGENT

ARTICLE 7 INITIAL DIRECTORS

The number of directors may be increased or decreased, but shall be not less than one, as specified by the shareholders from time to time. At any time, the shareholders may, by a majority vote, determine that the corporation be managed by the shareholders.
