The undersigned incorporator, for the purpose of Forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be Comturf Lawn Care, Inc.

ARTICLE II

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE III

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock havings a per value of \$.01 per share.
