The undersigned, acting as Incorporator of a corporation under the Florida General Corporation act, adopts the following Articles of Incorporation for such corporation:

**Article 1 - Name**

The name of this corporation is **FLORIDA AMBULATORY BEHAVIORAL HEALTH SYSTEMS CORP.**

**Article 2 - Mailing Address and Principal Office**

The corporation may adopt its by-laws at such time as determined by the Board of Directors.


Article 8 - Indemnification


