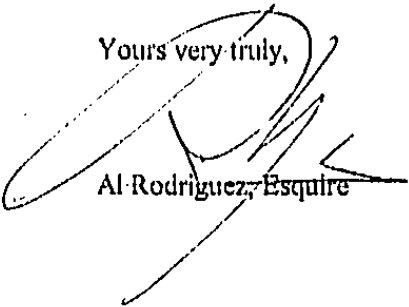

ARTICLES OF INCORPORATION
OF
INTERCD, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is INTERCD, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business address and mailing address of this corporation shall be 4618 S.W. 74th Avenue, Miami, Florida 33155.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock having a par value of \$.01 (one/hundredth of a dollar).

ARTICLE IV. REGISTERED AGENT AND INITIAL REGISTERED OFFICE.


The name of the initial registered agent whose business office is identical to the registered office is: DERVIS ALVAREZ.

The address of the registered office of the corporation is 4618 S.W. 74th Avenue, Miami, Florida.

The Board of Directors may from time to time move the registered office to any other address in the State of Florida.

ARTICLE V. ACCEPTANCE OF DESIGNATION AS REGISTERED AGENT

ARTICLE VI. BOARD OF DIRECTORS.

The Corporation shall have one director initially. The number of directors may be increased or diminished from time to time, as provided in the bylaws adopted by the shareholders, but shall never be less than one.
