ARTICLES OF INCORPORATION
OF
PROFESSIONAL TOUCH DRYWALL COMPANY, INC.

The undersigned subscriber to these Articles Of Incorporation hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is PROFESSIONAL TOUCH DRYWALL COMPANY, INC.

ARTICLE II - NATURE OF BUSINESS

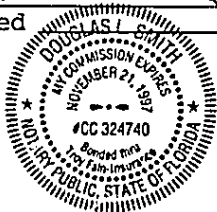
