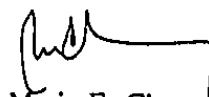

ARTICLES OF INCORPORATION
OF
DIAL ISDN, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME OF CORPORATION

The name of the Corporation is DIAL ISDN, INC.

ARTICLE II

ADDRESS

The initial principal office and mailing address of the Corporation is 11040 N.W. 7th Street, Plantation, Florida 33324.

ARTICLE III

CAPITAL STOCK

The Corporation is authorized to issue 3,000 shares of common stock, \$0.01 par value.

ARTICLE IV

PREEMPTIVE SHARES

The shareholders of this Corporation shall not be granted preemptive shares.

ARTICLE V

INITIAL REGISTERED AGENT AND OFFICE

ARTICLE VI

INCORPORATOR

ARTICLE VII

BOARD OF DIRECTORS

The number of directors constituting the Board of Directors shall be fixed by the Bylaws of the Corporation but shall not be less than one. NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the State of Florida.

These Articles of Incorporation or any amendment thereto may be amended in the manner authorized by law at the time of amendment.

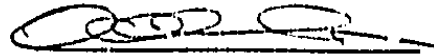
