

THE UNDERSIGNED, legally authorized to practice the profession of medicine in the State of Florida, has executed the following document as incorporator of the above named corporation, a professional corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporators, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

ARTICLE ONE: The name of the corporation shall be LEONARD A. SUKIENIK, D.O., P.A.

ARTICLE TWO: This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE THREE: The purpose for which the corporation is organized is to engage in the practice of the profession of medicine as a professional corporation and more specifically to engage in the practice of internal medicine and to render such services as may be ancillary thereto and transacting any and all business under the laws of the United States of America and the State of Florida.

ARTICLE FOUR: The aggregate number of shares which the corporation is authorized to issue is ONE HUNDRED (100). Such

shares shall be of single class, and shall have a par value of One and 00/100 (\$1.00) Dollar per share. None of the shares of this corporation may be issued to anyone other than an individual who is duly licensed to practice medicine in the State of Florida and whose license is in good standing.

ARTICLE FIVE: The street address of the initial registered office and principal place of business is 11903 Southern Boulevard, Suite 200, Royal Palm Beach, Florida 33411, and the name of its initial registered agent is LEONARD A. SUKIENIK, at the same address.






